Hi Gavin

Thank you for your application under section 241, Land Transport Act 1998 for access to names and addresses of individuals held on the Motor Vehicle Register and currently registered in respect of vehicles.

We note you are paying \$836, this was the pre-GST increase fee. The fee is now \$854.00. If you have already made an electronic deposit, can you please also pay the additional \$18.00.

Please note the Ministry is allowing up to 6 weeks from the time of receiving an application (together with full payment of the required fee) to be in a position to provide a 'draft' decision to the applicant. This is because applications are required to be sent to three external advisers for an opinion, before being put before a Panel for review. Once a draft decision is made and forwarded to an applicant, the applicant has 14 days to respond to that decision. Any additional information provided by the applicant will be carefully considered before a final decision is made. This means you may not have your draft decision before 1 May when the law changes. However, the Ministry will endeavour to get a draft decision to you as soon as possible.
